Take the preceding items to the Utilities Board office at 1607 2nd Ave E. Office hours are Monday through Friday, 8 a.m. to 4:30 p.m. Shorty after returning this form, physical verification of the installed natural gas logs may be required. If so, a Utilities Board representative will contact you.

Natural Gas Logs Rebate Terms and Conditions

- 1) The gas logs you are requesting a rebate for must be new natural gas logs and not originally liquefied propane gas logs that have been converted or modified to utilize natural gas.
- 2) The gas logs must be installed by a State of Alabama Certified Natural Gas Fitter in accordance with the International Fuel Gas Code.
- 3) The rebate form must be completed by you and your installing contractor.
- 4) You must include with the rebate form a receipt for the purchase of the gas logs and an installation receipt from the contractor that installed the gas logs.
- 5) The Utilities Board of the City of Oneonta may require a physical verification of the gas logs installation. If so, a Utilities Board representative will contact you to set up a meeting at the location of the installed gas logs.
