Trouble Spot Check List for Leaks

*Water tank on Commode: **(This is usually the #1 cause of issues)**

Seeping feed valve causing over-flow

Ball or flap valve not sealing

*Water heater filling or leaking, relieve valve open or seeping

*Dripping faucets in tub, shower, lavatory, sink, outside faucet etc...

*Washing machine or dishwasher feed valve open or seeping

*Hose in yard turned on or leaking

*Leaking pipes or fittings in house or in line between meter and house

*Swimming pool, fish pond, fountain etc...

*Water to air conditioning cooling tower running or leaking



***The Oneonta Utilities Board must have access to meters at all times.**

The Utilities Board of Oneonta is only responsible from the water meter to the main and the customer is responsible from the customer's side of the meter into the residence or business. The customer is responsible for sewer lines from the residence or business to main connection. Gas customers are responsible from the meter into the residence or business. However, if you ever smell gas inside or outside of your residence or business call The Utilities Board at 205-274-2159, toll free 1-866-274-5488 or call 911.

Oneonta Utilities Board bills are billed out monthly for usage for the previous month. Failure to receive your bill does not relieve customer of payment or penalty of late charges. There are approximately 30 days in each billing cycle. Please be aware due dates can vary from month to month, the date will always be listed on your bill. We do disconnect monthly for unpaid accounts. There is a \$75.00 disconnect fee if your payment is not in the office by 8:00 am on the morning of disconnection. If service is disconnected you must sign a new contract to get reinstated.
